During the first quarter of 2020, while economic uncertainty tasked Arizona companies with difficult decisions regarding office closures, reducing salaries, or furloughing or laying off employees, Burch & Cracchiolo celebrated its 50th anniversary by relocating its offices from North-Central Phoenix to the 17th floor of the BMO building located in downtown Phoenix.
